**LOCATION:** Top Notch Canine, 107 N 57th Drive Phoenix, AZ 85043

**ODORS:** Birch, Anise, Clove

**START TIME:** 10:00 a.m. walk through. Depending on the number of registrations, we may assign time slots to minimize wait time.

**COST:** \$30 per dog, per odor.

- Pre-payment is required.
- US funds check must be made payable to Now Who's The Boss, Inc. and mailed with your registration form to Jen Burkizer c/o NWTB 27413 N 60<sup>th</sup> Lane, Phoenix AZ 85083.
- Registrations will NOT be accepted without payment.
- A full refund will be given for cancellations received in writing (email is fine) before November 13.
- Entry fees shall not be refunded in the event that a dog is absent, disqualified, or excused by NACSW™ official or judge.

**REGISTRATION:**

- Limit of two dogs per handler. Each dog may test in up to three different odors. Each dog must be registered with the NACSW. A separate entry form must be completed for each dog.
- All dogs participating in the ORT must be registered with the NACSW™. All handlers must also be members of the NACSW™. Membership and registration are available at: <http://nacsw.net/nacswmembership.html>. Membership and Registration must be completed at least 6 weeks prior to the ORT to allow for processing time.
- Telephone, fax, unsigned entries, and entries received without fees cannot be accepted.
- RETURNED CHECKS do not constitute a valid entry fee. A charge of \$25.00 for each returned check.
- ENTRIES MUST BE MADE ON THE ATTACHED ENTRY FORM.
- NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED, WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.
- OWNERS are responsible for errors in making out entry forms.
- EXPRESS AND OVERNIGHT MAIL entries must waive required signature permitting them to be left at the address without recipient's signature.
- Acknowledgement of entry acceptance/CONFIRMATION will be made when entries are processed for those handlers that provide an email address. If you require a confirmation via USPS, you must provide a self-addressed stamped envelope with your entry.

## **DOG INFORMATION:**

- Dogs will not be permitted to roam.
- Exhibitors are responsible for the behavior of their dogs. The owner of each dog is solely responsible for having it ready when it is to be judged.
- Be prepared to keep your dog in your car when not being tested or on leash at all times. There is no inside crating at this test.
- All dogs must be on a 6' leash at all times when not being tested. While we don't allow flexi-leashes to be used to walk on the grounds of the testing site, if someone wants to run an ORT with their dog on a Flexi (or bungee), that is okay.
- FEMALES IN SEASON – Contact your test host if this becomes a possibility.
- Dogs in the ORT must be at least six months of age and must appear to be healthy on trial day and should be current on all vaccinations required by law.

## **GENERAL INFORMATION:**

Test location approximately 1 mile South of I10 and 59<sup>th</sup> Avenue. Limited shade but temperatures are usually in the 80's that time of year. Dogs waiting will remain in parking area in or near vehicles. Test will be held indoors, floor is Comfort King anti-fatigue matting from Crown Mats.

### Parking:

- Exhibitors (non-reactive dogs) will enter the parking area on the South side of the building and proceed behind the building to park. Exit out the North side of the parking lot.
- Exhibitors with reactive dogs will enter the parking lot of the neighboring building South of the test location.
- Volunteers park in the parking lot of the neighboring building North of the test location.

ORT participants are allowed to have a friend or family member video/photograph their test. ORT participants are not allowed to video/photograph one another. ORT hosts are not obligated to provide someone to video/photograph.
